## SI Re strengthens its underwriting and pricing with Maximilian Studer and Eric Dal Moro

Zug, 9 October 2025 – SIGNAL IDUNA Rückversicherungs AG (SI Re), a Swiss reinsurer headquartered in Zug, continues to invest in expanding its underwriting and pricing team. With Maximilian Studer as Underwriting Manager, the company is strengthening its presence in the Spanish, Portuguese as well as the German market. In addition, Eric Dal Moro, an experienced actuary, has been appointed Head of Pricing.

Maximilian Studer joined SI Re as Underwriting Manager in September. He will take over responsibility for the Spanish and Portuguese markets from Nicolas Schmidhauser, who will focus on the Eastern European markets going forward. He will also oversee the German market together with Thomas Bodenschatz. Maximilian Studer joins SI Re from Korean Re Switzerland AG, where since November 2021 he has been responsible as a P&C Underwriter for the DACH region (Germany, Austria, Switzerland). Previously, he worked for more than four years as a reinsurance broker at Aon Switzerland. Maximilian Studer holds a Master of Science in Engineering and Management as well as a Bachelor in Engineering Business Management from Coventry University.

Also in September 2025, Eric Dal Moro took over leadership of SI Re's pricing team. He succeeds Sascha Kälin, who took on the newly created position of Head of Analytics. Most recently, Eric Dal Moro served as Group Non-Life Chief Actuary at the Balaise Group. Previously, since 2021, he was responsible for Quantitative Risk Management at the health insurer Assura. From 2009 to 2019, he held various senior positions at SCOR, initially as Head of Group P&C Reserving and later as Head of Agriculture & Specialty Pricing. Before that, he worked at Swiss Re, Ernst & Young, and AXA. Eric Dal Moro is a member of the Swiss and French Institutes of Actuaries and CERA-qualified. He also served as Chair of the ASTIN Board of the International Actuarial Association. He graduated from the École des Mines de Saint-Étienne and holds a DESS in Business Administration from the University of Saint-Étienne.

Dr. Arnold Löw, CEO of SI Re, states: "With the appointment of Maximilian Studer, we are strategically strengthening our underwriting presence in our core market Germany, as well as across Iberia – a region with strong growth potential for SI Re. At the same time, we are investing in our actuarial capabilities by welcoming Eric Dal Moro.
